Parent's Requirements:

Cooperative nursery schools require parent participation. Our Summer requirements are as follows:

- 1) Submit a \$100 non-refundable deposit with your application. The remaining balance of \$50 for S1 Group or \$105 for S2 Group will be due at the Orientation Meeting.
- 2) Attend an evening Orientation Meeting on Thursday, June 18, 2009 from 7pm to 9pm.
- 3) Participate in the classroom one day per week (Negative TB test result must be presented prior to the first day of class)
- 4) Bring a snack and drink for your child
- 5) Perform at least 2 hours of maintenance as directed by the Maintenance Chair(s). Maintenance Party dates will be announced at the Orientation Meeting. A \$50 fine will be imposed if this obligation is not fulfilled.

How to Enroll for Summer School:

- 1) Please complete the following forms:
  - Application for Summer School – 2009
  - Membership/Admissions Agreement – Summer 2009
  - Certification and Authorization
  - Consent for Emergency Medical Treatment and Pick Up Authorization/Disaster Release Form
  - Physician's Report – Child Care Centers
  - Child's Immunization Records
  - Personal Rights – Child Care Facilities
  - Child Care Center Notification of Parents' Rights
  - Adult TB Test Verification (each adult participating in the classroom must submit a negative TB test/chest x-ray)
  - Child's Pre-Admission Health History – Parent's Report
- 2) Please include a check made payable to: Fremont Parents' Nursery School for \$100. This is a **non-refundable** deposit. Should you decide not to enroll, FPNS will keep this deposit.

- 3) The completed forms and deposit may be submitted in person by bringing them to the Centerville Campus or by U.S. mail to:
